It is understood by all parties that KEDC (Client), with Pam Middleton, as contact person, seeks to secure the presence of Dr. Travis Freeman, for its Life After High School Transition Fair, March 12-13, 2018

Performance Description

Dr. Freeman will provide keynote address at the event. He will also autograph copies of his literary works after the event's schedule of activities has concluded. Client shall provide one 8-foot table for display of Dr. Freeman's literary works as well as personnel for set up, display, and sales of his product. Dr. Freeman will need one (1) person to assist with crowds up to 200 and 2 for crowds over 200. Dr. Freeman shall assume responsibility for presence of product at the event.

Engagement Fee

Client hereby agrees to pay Dr. Freeman an engagement fee in the total amount of \$1500.00 for his presence and performance. A deposit of \$250 is due upon the signing of this contract. The remaining \$1250 is to be paid to Dr. Freeman, the day of the event. If the event is rescheduled, an additional rescheduling fee of \$250 will be required.

Accommodations and Expenses

It is understood that Dr. Freeman will coordinate travel for himself and one (1) travel companion and will provide the amount of such costs, which shall not exceed \$400.00, to the Client within two (2) business days of the Event. Client will provide reimbursement, for such costs, to Dr. Freeman within ten (10) days of receipt, of notification, of costs from Dr. Freeman.

Audio/Video Equipment

Dr. Freeman hereby grants permission to Client to take audio and video recordings of his performance at the Event. Such recording(s) shall be made available to Dr. Freeman for use at his discretion, as well as to those persons Client deems necessary. Any videotape reproduction is by the express permission of Dr. Freeman.

Client shall provide audio equipment for event in the form of a lavalier microphone, if available, or a hand-held microphone if it is not available.

Publicity for Public Events

It is understood that Event attendance is the sole responsibility of Client. It is further understood that Dr. Freeman retains the right to publicize his presence and performance at the Event.

Speaker Image Management

Travis Freeman shall approve all use of his photographic image by the client prior to its use. Such approval shall be given promptly upon request of Client and can be obtained via telephone or email.
