3.1. COVID-19 EMERGENCY LEAVE

Recommend Executive Director have the authority to allow paid sick leave to staff who test positive for Covid-19 or are required to quarantine due to exposure by the local Health Departments.

4.1. VACCINATIONS RECOMMENDED FOR STAFF

Due to the nature of the work that KEDC does being in and out of school district buildings on a daily basis, it has been highly recommended for staff to take the Covid-19 vaccination when available unless a medical or religious reason is provided. If medical or religious reason is provided, staff must seek written approval from the school district that allows them to work in-person without being vaccinated, if reasonable accommodations are not feasible or undue hardship is caused.

KEDC will be reapplying for funds through the Department of Justice. The original award was determined to be a duplication of services in the State, and we were asked to resubmit with a revised Scope of Work.
