Memorandum of Agreement Terms and Conditions

Revised December 2019

This Memorandum of Agreement (MOA) is entered into, by and between the Commonwealth of Kentucky, Kentucky Department of Education ("the Commonwealth") and the KENTUCKY EDUCATION DEVELOPMENT CORPORATION (KEDC) ("the Contractor") to establish an agreement to provide multiple quality professional development events (in-person and virtual), technical assistance and resource dissemination to assist schools with re-opening guidelines and strategies related to Coronavirus (COVID-19) per the Center for Disease Control (CDC) cooperative agreement (1801). The initial MOA is effective from August 10, 2021 to June 29, 2022.

Scope of Services:

The Kentucky Department of Education's Healthy Schools Team will contract with the Kentucky Education Development Corporation (KEDC) to provide multiple quality professional development events (in-person and virtual), technical assistance and resource dissemination to assist schools with re-opening guidelines and strategies related to Coronavirus (COVID-19) per the Center for Disease Control (CDC) cooperative agreement (1801). Additionally, KEDC (in partnership with Kentucky *First* Bluegrass) will develop videos illustrating best practices and strategies for school reopening and utilizing telehealth for school nurses and other school personnel.

Goals and Deliverables:

SEL Initiative

- * Conduct and/or utilize recent district/school needs assessment data to determine the social and emotional learning/climate (SEL/C) priorities of staff and students upon re-opening school facilities for student learning.
- * Plan (with KDE input) relevant professional development sessions to facilitate reopening guidance due to CIVID-19, to include, topics, presenters, agendas further enhancing social emotional learning/climate for students and staff.
- * Deliver professional development events addressing school/district reopening guidelines, best practices and strategies to enhance social emotional learning climate for students and staff.
- * Provide district and school technical assistance to facilitate school reopening support, including delivery of relevant social emotional learning/culture resources for a healthy and successful 20-21 school year.
- * Track, collect and report specific monthly evaluation data for professional development sessions, technical assistance and distributed resources per CDC cooperative agreement with the assistance of the grant evaluator and KDE staff. The monthly reporting tool to be used will be Title I Crate.
- * Participate in monthly cooperative/partner meetings to discuss grant activity, successes, challenges and needs for the initiative moving forward.

Terms and Conditions

Discrimination

Any suit, action or other proceeding regarding the execution, validity, interpretation, construction, or performance of this agreement shall be filed in the Franklin Circuit Court of the Commonwealth of Kentucky.

Requirement for Reporting to Kentucky Teachers Retirement System

Please note that, if any bidder to this solicitation is a current retiree of the Kentucky Teachers Retirement System ("KTRS"), or proposes to use a current or potential retiree of KTRS to perform any work under any contract, this may have an adverse impact upon retirement benefits for that retiree. Family Educational Rights and Privacy Act

If during the course of this agreement, KDE discloses to the contractor any data protected by the Family Educational Rights and Privacy Act of 1974 (FERPA), as amended, and its regulations, and data protected by the Richard B. Russell National School Lunch Act (42 U.S.C. 1751 et seq)(NSLA) and Child Nutrition Act of 1966 (42 U.S.C. 1771 et seq.)(CNA) the contractor is bound by the confidentiality, security and redisclosure requirements and restrictions stated in FERPA, NSLA and CNA and will enter into a confidentiality agreement and ensure its employees and contractors execute affidavits of nondisclosure as required by KDE.

As provided in KRS 61.931(5), a "non-affiliated third party" means "any person or entity that has a contract or agreement with the Commonwealth and receives (accesses, collects or maintains) personal information from the Commonwealth pursuant to the contract or agreement."

The contractor hereby agrees to cooperate with the Commonwealth in complying with the response, mitigation, correction, investigation, and notification requirements of the Act.

The contractor shall notify as soon as possible, but not to exceed seventy-two (72) hours, the contracting agency, the Commissioner of the Kentucky State Police, the Auditor of Public Accounts, and the Commonwealth Office of Technology of a determination of or knowledge of a breach, unless the exception set forth in KRS 61.932(2)(b)2 applies and the contractor abides by the requirements set forth in that exception. If the agency is an educational entity listed under KRS 61.931(1)(e), the contractor shall notify the Council on Postsecondary Education in the same manner as above. Notification shall be in writing on a form developed by the Commonwealth Office of Technology.

The contractor hereby agrees to report, immediately and within twenty-four (24) hours, any known reasonably believed instances of missing data, data that has been inappropriately shared, or data taken off site to my immediate supervisor, Associate Commissioner, and to the KDE Office for whom I perform work under the contract with KDE.

The contractor hereby agrees that the Commonwealth may withhold payment(s) owed to the contractor for any violation of the Identity Theft Prevention Reporting Requirements.

The contractor hereby agrees to undertake a prompt and reasonable investigation of any breach as required by KRS 61.933.

Upon conclusion of an investigation of a security breach of Personal Information as required by KRS 61.933, the contractor hereby agrees to an apportionment of the costs of the notification, investigation, and mitigation of the security breach.

In accordance with KRS 61.932(2)(a) the contractor shall implement, maintain, and update security and breach investigation procedures that are appropriate to the nature of the information disclosed, that are at least as stringent as the security and breach investigation procedures and practices established by the Commonwealth Office of Technology:

Student Data Security

Whereas, the first party, the state agency, has concluded that either state personnel are not available to perform said function, or it would not be feasible to utilize state personnel to perform said function; and Whereas, the second party, the Contractor, is available and qualified to perform such function; and Whereas, for the abovementioned reasons, the state agency desires to avail itself of the services of the second party;

NOW THEREFORE, the following terms and conditions are applicable to this contract:

1.00 Effective Date:

This contract is not effective until the Secretary of the Finance and Administration Cabinet or his authorized designee has approved the contract and until the contract has been submitted to the Legislative Research Commission, Government Contract Review Committee ("LRC"). However, in accordance with KRS 45A.700, contracts in aggregate amounts of \$10,000 or less are exempt from review by the committee and need only be filed with the committee within 30 days of their effective date for informational purposes.

KRS 45A.695(7) provides that payments on personal service contracts and memoranda of agreement shall not be authorized for services rendered after government contract review committee disapproval, unless the decision of the committee is overridden by the Secretary of the Finance and Administration Cabinet or agency head, if the agency has been granted delegation authority by the Secretary.

2.00 LRC Policies:

This section does not apply to governmental or quasi-governmental entities.

Pursuant to KRS 45A.725, LRC has established policies which govern rates payable for certain professional services. 3.00 Choice of Law and Forum:
