**Memorandum of Agreement Terms and Conditions**  
Revised January 2023

This Memorandum of Agreement (MOA) is entered into, by and between the Commonwealth of Kentucky, KENTUCKY DEPARTMENT OF EDUCATION (KDE “the Commonwealth”) and Kentucky Education Development Corporation (KEDC “the Contractor”) to establish an agreement to provide the Kentucky College and Career Advising Platform development. The initial MOA is effective from April 15, 2023 through September 30, 2023.

**Scope of Services:**

Funds will be used to support the development of a comprehensive college/career advising platform that can be utilized by K12, postsecondary, adult education and employer partners.

The Kentucky Department of Education (KDE), Kentucky Council on Postsecondary Education (CPE) and the Kentucky Education Development Corporation (KEDC Contractor) will work together and facilitate a partnership between KDE, CPE, and the Contractor to:

1. Support KDE and CPE with technical assistance that demonstrates a commitment to help Kentucky students through transition points in education to the workforce.
2. Support the development of a comprehensive college/career advising platform that can be utilized by K12, postsecondary, adult education and employer partners.

CPE, in a separate agreement, will outline their responsibilities with KEDC. These agreements will facilitate a partnership to support KDE and CPE with technical assistance that demonstrates a commitment to help Kentucky students through transition points in education to the workforce. The platform will be designed as a “one-stop-shop” for all resources that support strong college and career advising systems and will link existing Kentucky tools and reports that promote the state’s labor market and education data.

Any subcontract issued by the Contractor (KEDC) must be approved by KDE and CPE. Subcontractors must have staff and consultants with a deep expertise in the number of content areas spanning K – 12, higher education and workforce policy.

**Goals/Deliverables**

The Contractor will work with CPE, KDE and a technology vendor to ensure the completion of the website tool by the conclusion of the contract period. The Contractor will work with CPE and KDE to create, once the website has been made available for use, measurable goals that will be monitored, targeted training/awareness tool, and tools to help CPE and KDE monitor usage of the tool and exact impact data.

The Contractor will collaborate with KDE and CPE to facilitate and manage a project to create a website that meets the requirements set forth by CPE/KDE partnership. The Contract will facilitate the project utilizing the following: 1. Strategy: research

and preparation; 2. Design: visual look and custom design elements; 3. Build: vision into reality through content creation; 4. Test: extensive beta testing on browsers and devices; 5. Launch: moving to a live server; and 6. Report: making revisions and content updates.

The Contractor will work with KDE and CPE to ensure the technology vendor that focuses on a scope of work is to deliver a quality tested and secure a platform is as follows:

- # a login/reset for passwords.
- # inclusion of data sets from the Kentucky Center for Education and Workforce Statistics (KYSTATS).
- # information for the administrator that includes user management, survey builder, conditional logic, and content builder.
- # create a career explorer, the ability for the user to take a survey, view all content pages and explore the site.

The Contractor shall facilitate meetings with KDE and CPE every two weeks to discuss the following: a) review the deliverables; b) discuss future priorities; and c) create a plan for future task completion.

Partners (KDE and CPE) will: provide in-kind support for data collection and sharing with KYSTATS; manage the organization, communication and facilitation for all partner and stakeholder meetings; manage print and social media campaigns; and prepare contractual reports.

Since websites must have continual maintenance to keep them current and relevant, KDE and CPE also agree to financially support the sustainability of this project once the contractual period ends through a collaborative funding model and continued in-kind support to KYSTATS in subsequent years.

The contractor hereby agrees that the Commonwealth may withhold payment(s) owed to the contractor for any violation of the Identity Theft Prevention Reporting Requirements.

The contractor hereby agrees to undertake a prompt and reasonable investigation of any breach as required by KRS 61.933.

Upon conclusion of an investigation of a security breach of Personal Information as required by KRS 61.933, the contractor hereby agrees to an apportionment of the costs of the notification, investigation, and mitigation of the security breach.

**Student Data Security**

Pursuant to KRS 365.734, contractor shall certify in writing to the agency that it will comply with KRS 365.734(2).

Whereas, the Contractor may create, contribute to the creation, and/or have ownership interest in certain original works of authorship created pursuant to the terms of this contract;

And whereas, the Kentucky Department of Education (“KDE”) desires to acquire the entire interest of the Contractor in the original works of authorship created pursuant to the terms of this contract, and any copyrightable material which may be created pursuant to the terms of this contract;

Now therefore, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, the Contractor, hereby irrevocably assigns and transfers to KDE, its legal representatives, successors and assigns, all right, title, interest, and ownership in the original works of authorship and any copyrightable material which may be created pursuant to the terms of this contract, including copyrights, copyright registrations, and the right to procure United States and foreign copyrights registrations

**NOW THEREFORE**, the following terms and conditions are applicable to this contract:

**1.00 Effective Date**

This contract is not effective until the Secretary of the Finance and Administration Cabinet or his authorized designee has approved the contract and until the contract has been submitted to the Legislative Research Commission, Government Contract Review Committee ("LRC"). However, in accordance with KRS 45A.700, contracts in aggregate amounts of \$10,000 or less are exempt from review by the committee and need only be filed with the committee within 30 days of their effective date for informational purposes.

KRS 45A.695(7) provides that payments on personal service contracts and memoranda of agreement shall not be authorized for services rendered after government contract review committee disapproval, unless the decision of the committee is overridden by the Secretary of the Finance and Administration Cabinet or agency head, if the agency has been granted delegation authority by the Secretary.

**2.00 LRC Policies**
