**ARTICLES OF INCORPORATION  
OF  
EASTERN KENTUCKY EDUCATIONAL DEVELOPMENT  
CORPORATION**

**KNOW ALL MEN BY THESE PRESENTS:**

THAT WE, ORAN TEATER, Paintsville, Kentucky; GLENMORE HOGGE, Owingsville, Kentucky; HUBERT HUME, Maysville, Kentucky; W. C. SHATTLES, Ashland, Kentucky; ERNEST ROBINSON, Grayson, Kentucky; ~~ORLANDO WASSON, Morehead, Kentucky~~, and REEDUS BACK, Morehead, Kentucky, do hereby associate ourselves together to form and to help form under the provisions of KRS, Chapter 273, an educational and non-profit corporation.

**ARTICLE I.**

The name of this corporation shall be the **EASTERN KENTUCKY EDUCATIONAL DEVELOPMENT CORPORATION.**

**ARTICLE II.**

The purposes, objects and business proposed to be carried on, transacted and promoted by this corporation shall be confined to an Area known as Region 7 of Kentucky, composed of the following counties: Mason, Fleming, Robertson, Lewis, Rowan, Carter, Greenup, Boyd, Elliott, Morgan, Menifee, Bath, Magoffin, Johnson, Lawrence, Martin, Floyd and Pike, and in connection with this Area this corporation proposes to provide educational services currently unavailable therein to detect emotional or organic deficiencies in early childhood of children residing in this

region; to combat educational problems resulting from Regional isolation; to facilitate young people's transition from school to work; to speed educational practices and take into account students as individuals; to develop exemplary models for other schools in the State and to generally do all things necessary to advance the educational standards in the above Region, and in order to effectuate these purposes and aims this corporation shall have the power to receive grants and grants in aid from private, public and governmental sources; to have the power to expend such money as it may receive in the furtherance of any of its objects; to have power to employ competent and sufficient personnel to administer the program and accomplish the aims of this corporation; to have the power to establish one or more Centers throughout the Region, which will be necessary or will facilitate the development of this program; to have the power to contract or be contracted with; to enter into any and all types of contracts with individuals, firms or corporations or governmental agencies for the accomplishment of any of its purposes; to further have the right and power to accomplish any of the above named aims and purposes and the powers set forth herein shall not be deemed to be restrictive nor exclusive.

#### ARTICLE III.

The duration of this corporation shall be perpetual.

#### ARTICLE IV.

The principal office and place of business of this

corporation shall be in Morehead, Rowan County, Kentucky, and the resident agent for the service of process on this corporation shall be Mr. Reedus Back, whose address is 303 Flemingsburg Road, Morehead, Kentucky.

#### ARTICLE V.

There shall be no capital stock and no stockholders in this corporation.

#### ARTICLE VI.

The membership of this corporation shall be composed of the Superintendent of Schools, who are the executive officers or representatives of the respective Board of Education in the above named counties, and a representative of Morehead State College to be designated or appointed by the President.

#### ARTICLE VII.

The affairs of this corporation shall be governed by a Board of Directors, consisting of not less than nine (9) members, provided, however, the first Board of Directors shall be the Incorporators listed herein who shall serve until the first meeting of the membership of this corporation; thereafter, there shall be an annual election of the members of the Board of Directors. Any person who is a member of this corporation shall be eligible to serve as a member of the Board of Directors.

**ARTICLE VIII.**

The Board of Directors shall enact appropriate by-laws for the governing of this corporation, and said by-laws shall be adopted only by a majority vote of the members of the said Board.

**ARTICLE IX.**

This corporation shall commence business upon the proper recording of these Articles of Corporation and issuance of its certificate of Incorporation.

**ARTICLE X.**

The names and post office addresses of the first Board of Directors who are to serve until the first Board of Directors meeting of this corporation, are as follows:

**ARTICLE XI.**

The individual members of this corporation shall not be liable for any debt or obligation of this corporation.

ARTICLE XII.

There shall be no limit of indebtedness which the corporation may incur.

ARTICLE XIII.

This corporation is organized for exclusive charitable and educational purposes and shall be empowered only in the activities and furtherance of these purposes.

ARTICLE XIV.

In the event of the dissolution of this corporation, any assets will be disbursed for educational or charitable groups.
